I.

Preliminary Provisions

- The Partnership Agreement for the Implementation of the Project CULTPLAY Interactive
 Thematic Parks Innovative Use of Cultural Heritage within the Interreg V-A SlovakiaHungary Cooperation Programme (hereinafter referred to as "Agreement") was concluded
 between the Parties on 2018 February 8-th.
- 2. According the article No. 18 Concluding Provisions 1. of the Partnership Agreement any amendments to this Agreement shall be in writing and shall be signed by all Parties.

II.

Subject of the Addendum

The subject of this Addendum No.2 of the Parties' agreement is modification of articles and paragraphs as follows:

1. Article No.17 of the Partnership Agreement, paragraph 1. shall by replaced by followed:

"Parties agree that certain activities of the Beneficiary Kisbér Város Önkormányzata, Komárom Város Önkormányzata, Oroszlány Város Önkormányzata, Tata Város Önkormányzata will be implemented by the mayor's office as being the executive organ of the Beneficiary in accordance with Article 41(1) and 41(2) of Act No. CLXXXIX of 2011 on Local Governments in Hungary as well as paragraph 1 of Article 6/C of Act No. CXCV of 2011 on Public Finance, so that the costs reimbursed by the mayor's office are eligible for support."

III.

Final Provisions

- 1. The Agreement as amended does not alter in other provisions and it remains in force as a whole.
- This Addendum comes into force on the day when its written engrossment is signed by all Parties
 and it comes into effect on the day following the day of its publishing at website of Nové Zámky
 Municipality.
- 3. This Addendum is made in twenty two (22) counterparts, each Party will receive two original copy and Managing Authority will receive two original copies.
- 4. The Contractual Parties have duly read the Addendum, they have understood its contents and in witness whereof they sign it freely and seriously.
